**For sale of special cargo (except of agricultural products noted in Annex No.2) increasing coefficients are applied:**

- for perishable cargo - 1,2;
- for dangerous goods depending on class (for the 1st class - 1,5; for the 2nd, 3rd and 4th classes - 1,3; for the 5th, 6th, 7th and 8th classes - 1,25 and for the 9th class - 1,1; )
- for live animals (except bee's, turtles, rabbits and chickens less than age of 72 hours) from the normal published tariff with an increasing coefficient - 1,5;
- for live animals (bee's, turtles, rabbits and chickens less than age of 72 hours) - the normal published tariff applies.
