Notes to Annex No.2 dated March 29, 2026 (Agricultural Products)

a) In addition to the published rates, the following surcharges apply as indicated in the information section Cargospot → Master Data → Other/Local Charges:

- **EUR 0.15/kg (MYC)** — Fuel surcharge, calculated and payable based on the actual gross weight of the cargo, except for domestic (internal) routes;
- **EUR 9.00 (AWC)** — Documentation fee per one Air Waybill (AWB);
- **EUR 7.00 (MCC)** — Customs notification fee per one AWB for shipments destined to EAEU countries (Russian Federation, Belarus, Kazakhstan, Kyrgyzstan, Armenia), the United Kingdom, Israel, and the UAE;
- **EUR 20.00 (MCC)** — Customs notification fee per one AWB for shipments destined to the European Union and the United States.

Published rates are applicable for cargo uplifted as additional load on scheduled passenger flights.

b) **The rates indicated in Table No.1** shall apply only to agricultural products listed in Table No.2 (agricultural products marked with CORRATE codes).

c) **Agricultural products not listed in Table No.2 of Annex No.2** shall be transported according to the published rates for general cargo specified in Annex No.1.

d) **For agricultural products** requiring temperature control (codes COL, ERT, FRO, CRT), no rate coefficient shall be applied.

Terminal handling charges and airport fees at both origin and destination shall be borne by the shipper and consignee in accordance with established procedures.

Temperature-controlled cargo categories:

1. Refrigerated (COL) shipments to be maintained between + 2°C to + 8°C.
2. Controlled room temperature (CRT) shipments to be maintained between + 15°C to + 25°C.
3. Extended Room Temperature (ERT) shipments to be maintained between + 2°C to + 25°C.
4. Frozen (FRO) shipments to be maintained at -18°C or below during ground handling, frozen temperatures are not possible during air transportation and must be ensured via other means such as packaging solutions.

e) **Usage of agricultural products under CORRATE codes:**

1. Unified documentation of agricultural products:
When multiple agricultural products are shipped under a single AWB, indicate the code CORRATE in the Commod box for the first item.
The remaining product names and corresponding CORRATE codes must be reflected in the invoice.
The rate calculation shall be based on the total cargo weight.
2. Consolidation with other categories:
Consolidation of “Agricultural Products” with other cargo categories (including “General Cargo”) or among themselves under a single AWB is permitted.
Each cargo category shall be rated separately according to its total weight and the applicable tariff scale.
3. Unified rating within the same category:
When multiple items of agricultural products (with different CORRATE codes) are shipped under one AWB, the rate shall be calculated based on the total gross weight without separate rating per item.
The cargo description may be provided in a generalized form — e.g., “Agricultural Products (Perishable)”.
