## Notes to Annex No.1 dated March 29, 2026 (General Cargo)

a) In addition to the published rates, the following surcharges apply as indicated in the information section Cargospot → Master Data → Other/Local Charges:

- **EUR 0.25/kg (MYC)** — Fuel surcharge, calculated and payable based on the actual cargo gross weight, except for domestic (internal) routes;
- **EUR 9.00 (AWC)** — Documentation fee per one Air Waybill (AWB);
- **EUR 7.00 (MCC)** — Customs notification fee per one Air Waybill for shipments destined to member states of the EAEU (Russian Federation, Belarus, Kazakhstan, Kyrgyzstan, Armenia), the United Kingdom, Israel, and the UAE;
- **EUR 20.00 (MCC)** — Customs notification fee per one Air Waybill for shipments destined to the European Union and the United States.

Published rates are applicable for cargo uplifted as additional load on scheduled passenger flights.

For the sale of the following special cargo categories, the following rate adjustment factors (mark-up coefficients) shall apply to the published tariff rates:

**b) For perishable goods and agricultural products excluding those listed in Annexes No.2 and No.5**, including shipments requiring normal/or frozen temperature control (codes COL, ERT, FRO), a 1.2 coefficient shall be applied across the entire net rate scale (from MIN to +1000 kg).

The corresponding handling codes (COL, ERT, FRO) and specific temperature ranges indicated below must be entered in the Handling Information box of the Air Waybill (AWB).

1. Refrigerated (COL) shipments to be maintained between + 2°C to + 8°C.
2. Controlled room temperature (CRT) shipments to be maintained between + 15°C to + 25°C.
3. Extended Room Temperature (ERT) shipments to be maintained between + 2°C to + 25°C.
4. Frozen (FRO) shipments to be maintained at -18°C or below during ground handling, frozen temperatures are not possible during air transportation and must be ensured via other means such as packaging solutions.

Shipments requiring temperature control within the range of +15°C to +25°C (code CRT) shall be transported without applying any rate coefficient, while terminal handling charges and airport fees at both origin and destination must be paid by the shipper and consignee in accordance with established procedures.

**c) For live animals (AVI)**, apply the published NORM rate with a 1.2 coefficient. All terminal handling charges and airport fees at both origin and destination shall be borne by the shipper and consignee in accordance with established procedures.

**d) For dangerous goods (DGR)**, apply the following rate coefficients depending on the hazard class applicable across the full net rate scale from MIN to +1000 kg:

- **Class 1 -1.5;**
- **Classes 2, 3, 4 -1.3;**
- **Classes 5, 6, 7, 8 -1.25;**
- **Class 9 -1.1.**

**e) For other special cargo types**, apply the published rate scale without any coefficient. Terminal handling charges and airport fees at both origin and destination must be paid by the shipper and consignee as per the established procedures.
