**Notes to Annex No. 5 dated March 29, 2026
(Agricultural Products from domestic airports)**

a) In addition to the published rates, the following charges apply as indicated in the information section of Cargospot – Master Data – Other/Local Charges:

- **EUR 0.15 per kg (MYC)** – Fuel surcharge, calculated and payable based on the actual gross weight of the shipment, except for domestic (internal) routes;
- **EUR 9.00 (AWC)** – AWB documentation fee per Air Waybill;
- **EUR 7.00 (MCC)** – Customs pre-advice fee per Air Waybill for shipments to the customs authorities of EAEU countries (Russian Federation, Belarus, Kazakhstan, Kyrgyzstan, Armenia), the United Kingdom, Israel, and the UAE;
- **EUR 20.00 (MCC)** – Customs pre-advice fee per Air Waybill for shipments to EU and USA customs authorities.

The application of published rates is permitted for the additional loading of scheduled passenger flights.

b) **The rates specified in Table No.1** apply only to agricultural products listed in Table No.2 (agricultural commodities marked with CORRATE codes).

c) **Agricultural products not listed in Table No. 2 of Annex No.2** shall be transported under the published general cargo rates (Annex No. 1).

d) **For agricultural products requiring temperature control** (coded as COL, ERT, FRO, CRT), the rate uplift coefficient shall not apply.

In such cases, terminal handling charges and airport fees at origin and destination shall be borne by the shipper and consignee as per standard regulations.

Temperature-Controlled Cargo Requirements:

1. Chilled (COL) shipments must be maintained between +2°C and +8°C.
2. Extended Room Temperature (ERT) shipments must be maintained between +2°C and +25°C.
3. Frozen (FRO) shipments must be maintained at –18°C or below during ground handling. Sub-zero temperatures cannot be maintained in-flight and must therefore be ensured by ancillary means (e.g., packaging solutions) provided by the shipper.
4. Controlled Room Temperature (CRT) shipments must be maintained between +15°C and +25°C.

e) **Application of agricultural product codes (CORRATE):**

1. Uniform documentation of agricultural products:
When multiple shipments consisting exclusively of agricultural products are issued under a single AWB, the code CORRATE shall be entered in the “Commod” field for the first item, while the product names and corresponding CORRATE codes for subsequent items shall be indicated in the invoice. The rate shall be calculated based on the total chargeable weight of the shipment.
2. Consolidation with other cargo categories:
Consolidation of “Agricultural Products” with other cargo categories (including “General Cargo”) within one AWB is permitted. In such cases, each cargo category shall be rated separately based on the total weight according to the current tariff structure.
3. Unified rating within a single category:
When dispatching multiple items within one category (e.g., several agricultural products with different CORRATE codes under one AWB), the rate shall be applied based on the total shipment weight without separate calculation for each item. It is acceptable to indicate the commodity description in a generalized form, e.g., “Agricultural products (perishable)”.
