**Notes to Annex No. 6 dated March 29, 2026**  
**(Textile Products from domestic airports)**

a) In addition to the published rates, the following charges apply as indicated in the information section of Cargospot – Master Data – Other/Local Charges:

- **EUR 0.15 per kg (MYC)** – Fuel surcharge, calculated and payable based on the actual gross weight of the shipment, except for domestic (internal) routes;
- **EUR 9.00 (AWC)** – AWB documentation fee per Air Waybill;
- **EUR 7.00 (MCC)** – Customs pre-advice fee per Air Waybill for shipments to the customs authorities of EAEU countries (Russian Federation, Belarus, Kazakhstan, Kyrgyzstan, Armenia), the United Kingdom, Israel and the UAE;
- **EUR 20.00 (MCC)** – Customs pre-advice fee per Air Waybill for shipments to EU and USA customs authorities.

The application of published rates is permitted for additional loading on scheduled passenger flights.

b) **The rates specified in Table No.1** apply only to textile products listed in Table No. 2 (textile commodities marked with CORRATE codes).

For textile products not listed under CORRATE codes in Annex No. 3 and manufactured in the Republic of Uzbekistan and exported by local entrepreneurs or artisans, the CORRATE code 2455 (knitted and textile articles) shall be applied.

In such cases, the shipper and the Uzbekistan Airways cargo sales agent must provide a certificate of origin confirming that the goods were produced in Uzbekistan.

c) **Textile products not listed in Table No. 2 of Annex No. 3** shall be transported under the published general cargo rates (Annex No. 1).

d) **Application of textile product codes (CORRATE):**

1. Uniform documentation of textile products:  
When multiple consignments consisting exclusively of textile products are issued under a single AWB, the code CORRATE shall be entered in the “Commod” field for the first item, while the product names and corresponding CORRATE codes for subsequent items shall be indicated in the invoice. The rate shall be calculated based on the total chargeable weight of the shipment.
2. Consolidation with other cargo categories:  
Consolidation of “Textile Products” with other cargo categories (including “General Cargo”) within one AWB is permitted. In such cases, each cargo category shall be rated separately, based on the total weight, according to the current tariff structure.
3. Unified rating within a single category:  
When dispatching multiple items within one category (e.g. several textile products with different CORRATE codes under one AWB), the rate shall be applied based on the total shipment weight, without separate calculation for each item. It is acceptable to indicate the commodity description in a generalized form, e.g. “Textile and knitted products.”
